# Commander *Jim Bassett*

Oklahoma is 7<sup>th</sup> out of 14 Departments within the Southern Conference. Oklahoma is 38<sup>th</sup> out of 52 Departments within the Veterans of Foreign Wars. *As of 20 September 2021* 

Veterans Day is upon us. A time to reflect and remember. But never forget those still in uniform.

On October 18<sup>th</sup> of this year, the United States and veterans lost a great leader. He was a military leader and statesman. He was born April 5<sup>th</sup>, 1937 and passed away this October. He served as Chairman of the Joint Chiefs of Staff as well as Secretary of State. Collin Powell was a leader. Over the years he had developed rules of leadership as well as sayings on leadership that are extremely relevant today. Below are his 13 rules of leadership:

#### Rule No. 1: It ain't as bad as you think. It will look better in the morning.

There's a silver lining in every cloud, you just have to find it.

#### Rule No. 2: Get mad, and then get over it.

Anger is part of the normal range of human emotions.

#### Rule No. 3: Don't become so attached to an argument that if it fails, your ego goes with it.

Things aren't always going to go your way, that's just a fact of life. Be humble enough to accept that fact.

#### Rule No. 4: It can be done.

Just about anything can be accomplished if you set your mind to it, have the necessary resources, and the time to get it done.

#### Rule No. 5: Be careful what you choose. You may get it.

Don't rush into a bad decision. Take the time to consider your options, weigh the relevant facts, and make reasoned assumptions. Once you pull the trigger, there are no do-overs. So, make it count.

#### Rule No. 6: Don't let adverse facts stand in the way of a good decision.

Learn how to read a situation for yourself. Become the decision-maker your people need you to be.

#### Rule No. 7: You can't make someone else's decisions. (And don't let others make yours.)

Ultimately, you're responsible for your own decisions. Don't duck that responsibility and don't succumb to external pressures. Make your own decisions and live with them.

#### Rule No. 8: Check small things.

Leaders must have ways to check the little things without getting lost in them.

#### Rule No. 9: Share credit.

Don't be a glory hog. Share credit where credit is due and allow your people to stand in the spotlight. It ain't about you. It's about them.

#### Rule No. 10: Remain calm and be kind.

Keep calm and carry on. Kill 'em with kindness. When everyone is under incredible stress, be the leader people want to follow, not the leader people want to avoid.

#### Rule No. 11: Have a vision.

As a leader, part of your job is to articulate a vision that is worthy of their efforts.

#### Rule No. 12: Don't take counsel of your fears or naysayers.

Think clearly, think rationally, and make decisions that aren't rooted in emotion.

#### Rule No. 13: Perpetual optimism is a force multiplier.

People will feed off your optimism. Believe in your purpose, believe in yourself, and believe in your people. And they'll believe in you.

#### Here are some of Collin Powell's statements. His simple statements teach a lot.

#### *"Being responsible sometimes means pissing people off."*

Good leadership involves responsibility to the welfare of the group, which means that some people will get angry at your actions and decisions.

"The day soldiers stop bringing you their problems is the day you have stopped leading them."

They have either lost confidence that you can help them or concluded that you do not care. Either case is a failure of leadership.

"Don't be buffaloed by experts and elites. Experts often possess more data than judgment. Elites can become so inbred that they produce hemophiliacs who bleed to death as soon as they are nicked by the real world."

Real leaders are vigilant -- and combative -- in the face of these trends.

#### "Don't be afraid to challenge the pros, even in their own backyard."

Learn from the pros, observe them, seek them out as mentors and partners. But remember that even the pros may have leveled out in terms of their learning and skills. Good leadership encourages everyone's evolution.

#### "You don't know what you can get away with until you try."

You know the expression "it's easier to get forgiveness than permission?" Well, it's true. They're prudent, not reckless. So, the moral is, don't ask.

# *"Keep looking below surface appearances. Don't shrink from doing so (just) because you might not like what you find."*

"If it ain't broke, don't fix it" is the slogan of the complacent, the arrogant or the scared. It's an excuse for inaction, a call to non-arms.

#### "Organization charts and hence titles count for next to nothing."

Organization charts are frozen, anachronistic photos in a workplace that ought to be as dynamic as the external environment around you.

*"Fit no stereotypes. Don't chase the latest management fads. The situation dictates which approach best accomplishes the team's mission."* 

Leaders honor their core values, but they are flexible in how they execute them. They understand that management techniques are not magic mantras but simply tools to be reached for at the right times.

# *"Great leaders are almost always great simplifiers, who can cut through argument, debate and doubt, to offer a solution everybody can understand."*

Effective leaders understand the KISS principle, or Keep It Simple, Stupid. The result? Clarity of purpose, credibility of leadership, and integrity in organization

# "The commander in the field is always right and the rear echelon is wrong, unless proved otherwise."

Shift the power and the financial accountability to the folks who are bringing in the beans, not the ones who are counting or analyzing them.

# *"Have fun in your command. Don't always run at a breakneck pace. Take leave when you've earned it. Spend time with your families."*

Corollary: "Surround yourself with people who take their work seriously, but not themselves, those who work hard and play hard."

#### "Command is lonely"

The essence of leadership is the willingness to make the tough, unambiguous choices that will have an impact on the fate of the organization. I've seen too many non-leaders flinch from this responsibility.

#### "All work is honorable. Always do your best because someone is watching."

If Soldiers see a leader slack on the mundane matters, they won't have confidence that he can competently lead them into combat.

#### "Control enthusiasm in the face of victories, large or small."

The concept that followers will take their cues from the leader and to maintain composure and cognition when things are going your way, and when they're not.

#### "Dig up all the information you can, then go with your instincts."

Rather than try to think your way through complex problems, it's better to trust that internal voice. The subtle magic is that by digging up all the information you can, you feed and *inform* your instincts.

#### "You don't step on enthusiasm."

Encourage people when they show initiative and enthusiasm. Even if their ideas are underdeveloped or not quite realistic, guide them into more productive areas without crushing their spirit.

#### "Never believe the first thing you hear."

There is *always* more to the story, there are more perspectives to consider. Rarely should leaders act on a single piece of information, especially in the military when the activities routinely involve risk to life or contact with an enemy.

Collin Powell taught us many things. He taught me many things. He will be missed.

If your post or district is going to host or participate in a major event, please let the department know. We do have vendors that may help your event. We cannot ask them if we do not know about them. Please help the department get word out.

Recruiting versus retention. If we retain our members, then to grow we when we recruit. As it is, we must recruit 2 new members. One to grow and one to replace the members leaving. What are you doing to keep your members?

I have been asked if I have a special project. The answer is no. I'm concentrating on retention. I do have something that I'm very interested in supporting. My class of commanders has created a perpetual Voice of Democracy scholarship. Currently it is only a \$1,000 to the recipient, almost at the \$1,500 threshold. The more money donated to the scholarship, the more can be awarded to the recipient. This can be a depressing time of year for many, keep an eye out and check with people. Buddy Checks. Stay healthy, stay on top of deadlines, but mostly, remember to have fun. We have many wonderful opportunities out there; we just need to capitalize on them.

Comrades, Brothers and Sisters,

Greetings!! I hope all of you are doing well and those that are not, I wish you a speedy recovery. Below I have written the information concerning the VFW Top Priority Goals in front of the current Congress. Rebecca Merit, the Auxiliary Legislative Chair, and I met with Senator's Inhofe and Lankford offices as well as Representative's Hern, Cole and Lucas offices to discuss these matters. Most all the bills were well received, especially the GWOT Memorial Location Act because it was budget neutral. However, as you will see below, most of the main bills the VFW is supporting is not supported by our congressional delegation. We must change that. As I have said so many times before, our voice in Congress is only as big as you make it. That means we need each one of you involved to ensure these bills pass.

Below, not only have I provided the bills, but there is also a short description of the bill, its status and how many Oklahoma cosponsors there are, if any. Below them is the contact information for both of our senators and all five of our representatives. Please utilize them to contact their offices expressing your desire for them to cosponsor these bills as soon as possible.

If there is one bill that I would especially ask you to focus on is asking Senator Inhofe to cosponsor the Major Richard Star Act and to add it to the National Defense Authorization Act

to ensure it passes this year. This is a vital piece of legislation and is the first "foot in the door" allowing retired veterans to receive not only their retirement, but also their disability without an offset. Senator Inhofe is on the verge of signing on to the bill. So, if we all speak with one clear voice, I truly believe that we can ensure it becomes law this year. What a great way to honor the legacy of a truly honorable veteran who is no longer with us.

**S.3003 Comprehensive and Overdue Support for Troops (COST) of War Act of 2021** or the SFC Heath Robinson Burn Pit Transparency Act - An original bill to improve health care and benefits for veterans exposed to toxic substances. Placed on Senate Legislative Calendar. **Oklahoma Senator cosponsors: 0** 

**HR. 3967 Honoring our Promise to Address Comprehensive Toxics (PACT) Act of 2021** or COVENANT Act, Conceding Our Veterans' Exposures Now And Necessitating Training Act, FASTER Presumptions Act, Fair Care for Vietnam Veterans Act, Fairly Assessing Service-related Toxic Exposure Residuals Presumptions Act, Mark Takai Atomic Veterans Healthcare Parity Act, Palomares Veterans Act, Presumptive Benefits for War Fighters Exposed to Burn Pits and Other Toxins Act, TEAM Act, Toxic Exposure in the American Military Act, Veterans Agent Orange Exposure Equity Act, Veterans Burn Pits Exposure Recognition Act - To improve health care and benefits for veterans exposed to toxic substances. Passed House Committee on Veterans' Affairs. Oklahoma Representative cosponsors: 0

**S. 976 Caring for Survivors Act of 2021** - This bill increases the monthly rate of dependency and indemnity compensation payable to surviving spouses through the Department of Veterans Affairs. The bill also adjusts the amount payable to surviving spouses and children of veterans who were rated as totally disabled for a period of less than 10 years before their death. Senate Committee on Veterans' Affairs. Oklahoma Senator cosponsors: 0

**HR.3402 Caring for Survivors Act of 2021** - This bill increases the monthly rate of dependency and indemnity compensation payable to surviving spouses through the Department of Veterans Affairs. The bill also adjusts the amount payable to surviving spouses and children of veterans who were rated as totally disabled for a period of less than 10 years before their death. House Veterans' Affairs Subcommittee on Disability Assistance and Memorial Affairs hearings held. **Oklahoma Representative cosponsors: 0** 

S. 535 Global War on Terrorism Memorial Location Act - This bill authorizes the establishment of a National Global War on Terrorism Memorial in the area of the National Mall. Senate Committee on Energy and Natural Resources
Subcommittee on National Parks hearings held. Oklahoma Senator cosponsors: 2 (Inhofe and Lankford)
HR. 1115 Global War on Terrorism Memorial Location Act - This bill authorizes the establishment of a National Global War on Terrorism Memorial in the area of the National Mall. Referred to the House Subcommittee on National Parks, Forests, and Public Lands. Oklahoma Representative cosponsors: 4 (Cole, Lucas, Hern and Bice)

**S. 1093 Department the Veterans Economic Opportunity and Transition Administration** - This bill establishes the Veterans Economic Opportunity and Transition Administration to administer economic opportunity assistance programs for veterans and their dependents and survivors. Specifically, the Veterans Economic Opportunity and Transition Administration must administer the following Department of Veterans Affairs (VA) programs, vocational rehabilitation and employment programs, educational assistance programs, veterans' housing loan and related programs, the Transition Assistance Program, and the database of small business concerns owned and controlled by veterans. Prior to the transfer of administrative responsibilities, the bill requires the VA to certify that (1) the transition of the provision of services will

not negatively affect the provision of such services to veterans, and (2) such services are ready to be transferred. Senate Committee on Veterans' Affairs hearings held. **Oklahoma Senator cosponsors: 0** 

**S. 2172 Building Solutions for Veterans Experiencing Homelessness Act of 2021** - A bill to amend title 38, United States Code, to improve grants, payments, and technical assistance provided by the Secretary of Veterans Affairs to serve homeless veterans. Senate Committee on Veterans' Affairs hearings held. Oklahoma Senator cosponsors: 0

**S. 444 Advancing Uniform Transportation Opportunities for Veterans Act or the AUTO for Veterans Act -** This bill authorizes the Department of Veterans Affairs (VA) to provide (or assist in providing) an eligible veteran or service member with an additional automobile or other conveyance under the VA automobile allowance and adaptive equipment program. Currently, a veteran or service member with a specified service-connected disability or impairment may not receive more than one automobile or other conveyance under the program. The bill authorizes the additional benefit for such veterans and service members if 10 years have passed since the person last received such benefit. Senate Committee on Veterans' Affairs hearings held. Oklahoma Senator cosponsors: 0

**HR. 1361 Advancing Uniform Transportation Opportunities for Veterans Act or the AUTO for Veterans Act** - This bill authorizes the Department of Veterans Affairs (VA) to provide (or assist in providing) an eligible veteran or service member with an additional automobile or other conveyance under the VA automobile allowance and adaptive equipment program. Currently, a veteran or service member with a specified service-connected disability or impairment may not receive more than one automobile or other conveyance under the program. The bill authorizes the additional benefit for such veterans and service members if 10 years have passed since the person last received such benefit. Referred to the House Subcommittee on Economic Opportunity. Oklahoma Representative cosponsors: 0

**HR. 2335 VET TEC Enhancement Act of 2021 -** This bill increases the amount authorized to be appropriated for the Department of Veterans Affairs (VA) High Technology Pilot Program from \$45 million to \$125 million for FY2022 and each succeeding year. The High Technology Pilot Program provides eligible veterans with the opportunity to enroll in high technology programs of education that the VA determines provide training or skills sought by employers in a relevant field or industry. Referred to the House Subcommittee on Economic Opportunity. **Oklahoma Representative cosponsors: 1 (Lucas)** 

**S. 344 Major Richard Star Act** - This bill allows a veteran with a combat-related disability and fewer than 20 years of creditable service to receive retirement pay, without reduction, concurrent with disability compensation. Referred to the Senate Committee on Armed Services. Oklahoma Senator cosponsors: 0

**HR. 1282 Major Richard Star Act** - This bill provides that combat-disabled uniformed services retirees with fewer than 20 years of creditable service may concurrently receive, without reduction, veterans' disability compensation and retired pay or combat-related special compensation. Referred to the House Subcommittee on Disability Assistance and Memorial Affairs. **Oklahoma Representative cosponsors: 3 (Cole, Mullin, Hern)** 

**S. 1291 Record of Military Service for Members of the Armed Forces Act of 2021** - A bill to provide for a standard record of service on active duty for members of the reserve components of the Armed Forces, and for other purposes. Referred to the Senate Committee on Armed Services. **Oklahoma Senator cosponsors: 1 (Lankford)** 

**S. 1611 I am Vanessa Guillén Act of 2021** - A bill to amend title 10, United States Code, to improve the responses of the Department of Defense to sex-related offenses, and for other purposes. Referred to the Committee on Armed Services. **Oklahoma Senator cosponsors: 0** 

**HR. 3224 I am Vanessa Guillén Act of 2021** - To amend title 10, United States Code, to improve the responses of the Department of Defense to sex-related offenses, and for other purposes. Referred to the House Committee on Armed Services. **Oklahoma Representative cosponsors: 3 (Cole, Mullin, Hern)** 

**S. 1944 Vet Center Improvement Act of 2021** - A bill to improve Vet Centers of the Department of Veterans Affairs, and for other purposes. Senate Committee on Veterans' Affairs hearings held. **Oklahoma Senator cosponsors: 0** 

**HR. 3575 Vet Center Improvement Act of 2021** - To improve Vet Centers of the Department of Veterans Affairs, and for other purposes. Referred to the House Committee on Veterans' Affairs. **Oklahoma Representative cosponsors: 0** 

**HR. 4233 Student Veterans Counseling Centers Eligibility Act** - To amend title 38, United States Code, to furnish Vet Center readjustment counseling and related mental health services to veterans and members of the Armed Forces using certain educational assistance benefits. Referred to the House Subcommittee on Health. Oklahoma Representative cosponsors: 0

**HR. 239 Equal Access to Contraception for Veterans Act** - This bill prohibits the Department of Veterans Affairs from requiring payment from a veteran for any contraceptive item that is required to be covered by health insurance plans without a cost-sharing requirement. Passed the House, received in the Senate and referred to the Senate Committee on Veterans' Affairs. **Oklahoma Representative cosponsors: 0** 

**S. 796 Protecting Moms Who Served Act of 2021 -** This bill requires the Department of Veterans Affairs (VA) to implement the maternity care coordination program. The VA must provide community maternity care providers (i.e., non-VA maternity care providers) with training and support with respect to the unique needs of pregnant and postpartum veterans, particularly regarding mental and behavioral health conditions in relation to the service of the veterans in the Armed Forces. Additionally, the Government Accountability Office must report on maternal mortality and severe maternal morbidity among pregnant and postpartum veterans, with a focus on racial and ethnic disparities in maternal health outcomes for veterans. Passed Senate with an amendment by Unanimous Consent, Received in the House, and held at the desk. **Oklahoma Senator cosponsors: 0** 

**HR. 958 Protecting Moms Who Served Act** - This bill requires the Department of Veterans Affairs (VA) to implement the maternity care coordination program. The VA must provide community maternity care providers (i.e., non-VA maternity care providers) with training and support with respect to the unique needs of pregnant and postpartum veterans, particularly regarding mental and behavioral health conditions in relation to the service of the veterans in the Armed Forces. Additionally, the Government Accountability Office must report on maternal mortality and severe maternal morbidity among pregnant and postpartum veterans, with a focus on racial and ethnic disparities in maternal health outcomes for veterans.
