General Orders No. 03 2021-2022 Series

1. Pursuant to National By-Laws Article VII Miscellaneous Provisions, Section 703, Bonds, "Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post, as the case may be, to which each officer is accountable.

The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit."

- 2. *Trustee's Report of Audit:* Posts & Districts are reminded to forward their Trustees' reports at the end of each quarter of the current year: June 30th, Sep 30th, Dec 31st and March 31st. Send these audit reports to VFW-OK, P.O. Box 1126, Oklahoma City, OK 73101 or emailed to vfwhqokqm@outlook.com
- 3. Attention of Post & District Commanders & Quartermasters: Commanders & Quartermaster are reminded at all levels of the annual requirement to complete an IRS 990, IRS 990N, for tax exemption requirements. Failure to complete the required IRS 990 may result in loss of tax-exemption status.
- 4. *Department Directory/Roster:* Commanders & Adjutants are asked to send all corrections, changes etc. of the Department Roster to wfwhqoklahoma@outlook.com for changes.
- 5. *District Meetings Dates & Changes:* District Commanders are reminded to notify the State Adjutant at wfwokadj@outlook.com of any changes to district meetings including new dates for District meetings.

A VFW Message to Veterans in the Wake of Recent Events in Afghanistan

The following is a message from VFW National Commander Fritz Mihelcic

With the recent turn of events in Afghanistan, the Veterans of Foreign Wars (VFW) wants the veterans of the war in Afghanistan to know we stand with you. Scores of VFW members know the anger, frustration, and sadness you are experiencing after hearing the troubling reports and seeing the disturbing images coming from lands where we sacrificed so much. From the fall of Saigon in Vietnam, to the withdraw from Somalia after the battle of Mogadishu, to the ISIS take-over of Fallujah, Ramadi, Mosul, and Tikrit, far too many of us have experienced the heavy burden of loss, disappointment, and helplessness our newest generations of veterans may be feeling watching the Taliban return to power.

However, while there is bitter sentiment over this withdrawal, we encourage you to hold your head high. 

Department Service Officer notes:

- 1. We have been looking for someone to work out of the Regional Office in Muskogee, OK. We have several individuals interested in that position. The Department is sitting a September 7, 2021, date as a cutout for any more individual to forward their resume.
- 2. Several individuals have expressed interest in the position or getting accreditation, but not in Muskogee. The Department will be developing a plan to present to the National Veterans Services Director in the future to allows for these individual. If you are interested forward a current resume. Include where and how this would benefit the entire department. This training will cost around 15K for the first two years. National Veterans Service Policy & Procedure outline the guidelines that we as a department must follow.
- 3. This past month Bill, Robbie, and I visit the OKC VA Center to discuss the New Family Caregivers program. Under the VA MISSION ACT of 2018, The VA has expanded this program. First and foremost, remember that this program is offered from the medical side of the VA. https://www.caregiver.va.gov/pdfs/FactSheets/CSP_Eligibility_Criteria_Factsheet_1-4-21.pdf#

https://www.caregiver.va.gov/pdfs/FactSheets/ApplicationProcessFactsheet_1-13-21.pdf# A major concern is the 3 Assessment area of the application process. These areas are: The veteran Assessment, Caregiver assessment and the Veteran Functional Assessment Instrument. The VA and a Centralized Eligibility and Appeals Team (CEAT) will conduct a review of the application and the three assessment which is internal to the VA. If the veteran receives a

application and the three assessment which is internal to the VA. If the veteran receives a denial letter, they will have to appeal to the medical team. This is not the normal appeal process most veteran is familiar with.

4. Also this past month "The Department of Veterans Affairs (VA) is issuing this interim final rule to amend its adjudication regulations to establish presumptive service connection for three chronic respiratory health conditions, i.e., asthma, rhinitis, and sinusitis, to include rhinosinusitis, in association with presumed exposures to fine, particulate matter. These presumptions would apply to veterans with a qualifying period of service, i.e., who served on active military, naval, or air service in the Southwest Asia theater of operations during the Persian Gulf War (hereafter Gulf War), as well as in Afghanistan, Syria, Djibouti, or Uzbekistan, on or after September 19, 2001, during the Gulf War." We need to apply for these conditions and if they were denied in a pass rating an appeal will need to be developed and forward to our office in Muskogee.

DEPARTMENT OF OKLAHOMA VETERANS OF FOREIGN WARS OF THE UNITED STATES VETERANS AFFAIRS ACCREDITED SERVICE OFFICERS

BASIC PURPOSE:

The Veterans Service Officer is assigned responsibilities involving the coordination of benefits and other related services for eligible veterans and their dependents and as a legal representative/Power of Attorney on their behalf before U.S. Department of Veterans Affairs (VA) Federal boards. The Veterans Service Officer serves as an advocate for eligible veterans to maximize services and benefits for themselves and their families. The Veterans Service Officer also serves as a liaison to other Federal and State agencies in matters related to veterans' services and benefits.

TYPICAL FUNCTIONS:

Functions in this job vary by position, however, will include the following:

- 1. Interviews veterans and families to assess their needs and eligibility relating to receipt of State and Federal benefits in the areas of medical treatment, disability compensation, insurance, pension, debt management, education, training, and rehabilitation.
- 2. Performs case management duties throughout assessment by researching information, compiling reports, filing claims, formulating appeals, obtaining benefits, interpreting laws to include rules, regulations, and procedures.
- 3. Provides assistance in the completion of required forms, counsels and assists clients in utilization of appropriate resources, identifies deficiencies and develops a strategy to initiate actions necessary to obtain maximum benefits.
- 4. Advises clients regarding documentation needed to support benefit claims which may include making referrals to other agencies and resources.
- 5. Reviews rating board decisions assuring compliance with Title 38 U.S. Code of Federal Regulations, determining if an appeal is warranted.
- 6. Initiates the appeal process by preparing a written brief outlining the basis of disagreement and obtains client's Power of Attorney to utilize, as necessary.
- 7. Prepares financial statements and interprets the correlation of Social Security, military retirement, other income, and net worth affecting VA pension and compensation.
- 8. Assists client in dealing with VA Debt Management Agency by preparing financial reports to support client's request for waiver, postponement, compromise offers, or repayment plan for benefit overpayment.
- 9. Independently reviews client VA files, evaluating evidence including veteran's service and post service medical records, as well as service history.
- 10. Research laws, regulations, policies, and case law/precedent decisions from VA Board of Veterans Appeals and U.S. Court of Veterans Appeals.
- 11. Assists veterans in preparing for hearings, writing appeal briefs on issues that were previously adjudicated at a lower level.
- 12. Acts as claimant's legal representative during informal hearings before VA decision review officers, formal hearings before VA administrative hearing officers and Board of Veterans Appeals administrative law judges.
- 13. Presents oral arguments and sworn testimony during hearings through a series of questions that are supportive of the issues on appeal.
- 14. Plans/develops curriculum, conducts and coordinates training seminars, certification training for Post and District service officers, and others if requested.
- 15. Develops, maintains, and coordinates comprehensive veterans' outreach and public information programs including certification through Veterans Affairs Regional Office.
- 16. Serves as agency liaison and guest speaker at civic functions.

LEVEL DESCRIPTIONS

The Veterans Service Officer's job consists of three levels which are based on the complexity of work assigned, the level of expertise required to perform assigned duties, the location of specific positions and the responsibility for the leadership of others.

Claim Consultant, Level I

This is the basic level. Employee performs entry level tasks to build skills in the processing of claims and services based on Federal and State laws and regulations endeavoring to assure the entitlement and receipt of appropriate benefits.

Practices counseling veterans and their dependents concerning benefits and services. Under close supervision, limited responsibility pay be assigned for preparation of written briefs outlining evidence supportive of issues.

- 1. Under appellant review or assignments, act as representative of veteran/client before decision review officers, administrative hearing officers, and administrative law judges
- 2. Limited responsibilities may be assigned for providing training or assistance to others, including administrative support personnel, in providing appropriate services.

Knowledge, Skills and Abilities (KSA)

- 1. KSA requires knowledge of Federal/State statutes/regulations pertaining to veterans' benefits programs consisting of Social Security, Worker's Compensation and applicable rules, policies, and programs that affect said benefits.
- 2. Basic benefit counseling and interviewing techniques of common adjustment problems experienced by veterans is the goal.
- 3. The Claims Consultant must have the ability to independently research laws, regulations, policies, and precedent decisions for appellant cases.
- 4. Communicate effectively, both orally and in writing as well as have the ability to follow written and oral instructions. (Use of various software and agency specific computer programs and establishing/maintaining effective working relationships is needed.)

Education and Experience

Requirements at this level consist of a bachelor's degree from an accredited college or university or an equivalent combination of education and experience, substituting one year of work experience in the military or veterans' programs for each year of the required education.

Assistant Department Service Officer, Level II (ADSO)

This is the Specialist level. Employee is assigned responsibilities involving advanced level work requiring a high level of technical expertise, including the leadership skills providing benefits and services to veterans, i.e., a project leader or other comparable duties. ADSO may supervise clerical or administrative support staff.

Knowledge, Skills and Abilities (KSA)

KSA required at this level include skills identified in Level I, plus the ability to provide assistance and services to eligible veterans and their families. ADSO must have knowledge of effective supervisory principles and practices, ability to organize and conduct several programs simultaneously and exercise sound judgement analyzing complex situations while adopting appropriate courses of action.

Education and Experience

Requirements at this level consist of those identified in Level I plus one (1) additional year of experience working veterans' programs.

Department Service Officers, Level III (DSO)

This is the leadership level. Employee is required to have a clear specialization in the occupational family and is responsible for:

- 1. Administering major program components of the claims and benefits program
- 2. Managing daily operations dealing with claims/benefits and appeals at a regional claims office or Veterans Affairs claims office.

Knowledge, Skills and Abilities (KSA)

KSA at this level consist of those identified in Assistant Department Service Officers.

Education and Experience

Requirements are those identified in Level II plus two (2) additional years of advanced level work in providing benefits and services through programs for veterans.

SPECIAL REQUIREMENTS

- 1. Applicant for Claims Consultant must meet KSA, education and experience as listed, but is not required to be a veteran. However, if they are a veteran, they must meet item two (2) of the Special Requirements.
- 2. Applicant for DSO and ADSO must be a veteran of the U.S. Armed Forces, discharged under honorable conditions, and must be a member of the Veterans of Foreign Wars of the United States (VFW), Department of Oklahoma.
- 3. Applicant applying for DSO, ADSO and Claim Consultant must obtain accreditation (which has been certified by the VA) from the VFW National Headquarters within six months of employment.
- 4. Applicant must be willing and able to fulfill all job-related travel requirements associated with this these positions.
- 5. Applicant must meet requirements and be in compliances as outlined in the VFW National Veterans Service Policy and Procedure.

National Council Member

Human Resources: New Employee: Brittany Dymond is our new Associate Director National Legislative Service in the Washington office. Communications: The C&PA director is coordinating with the VFW Membership and VFW Foundation deputy directors for podcast coverage of the Sturgis Motorcycle Rally in Sturgis, South Dakota. The C&PA director and the VFW Foundation are working out details of podcast coverage of the Sports Clips National

Huddle in San Antonio, Texas. The C&PA director is planning future media training for new chair officers and social media presentations at fall conferences. Administrative Operations There are currently 43 Posts under suspension. We are currently working three Post Consolidations pursuant to Section 209 of the National Bylaws, five charter surrenders pursuant to Section 210 of the National Bylaws, and one charter revocation pursuant to Section 212 of the National Bylaws. The organization has 5,977 chartered Posts. Administrative Operations is engaged in 20 Article IX Disciplinary Actions, three of which are pending disciplinary hearings; four administrative actions; and one membership eligibility challenge. Administrative Operations has processed, approved, and distributed 14 Bylaws/Articles of Incorporation this week. We have received five new Bylaws/Articles of Incorporation submissions and currently have 10 total pending review and approval. Current turnaround time on Bylaws/Articles of Incorporation submissions is approximately eight days. Meetings and Events Ongoing Completion of remaining hotel contracts for 2022 Convention – Kansas City that were put on hold to work through 2021 convention contracts. Review and forward to legal contracts – KCI Airport Marriott Hotel for the 2021 Jr. Vice, 2022 Jr. Vice, and 2022 Sr. Vice meetings. Reviewed and forwarded convention 2021 related final invoices to accounting for payment. Schedule meeting with KCI Airport Marriott to review protocols for upcoming September Budget/Finance & Council of Administration meeting. Prepare resume (meeting specifications) for September Budget Finance/Council of Administration meeting. VFW Foundation the VFW Foundation conducted a highly successful "Grants and Fundraising Ideas for Posts" workshop at the 122nd VFW National Convention in Kansas City, Missouri. National Legislative Service Take Action Now on VFW-Supported Toxic Exposure Bills: If you haven't already done so, we encourage all veterans, family members, friends, and supporters to Take Action Now. Spread the word so that as many people as possible will contact their senators and representatives to support these important pieces of legislation! VA Begins Processing New Presumptive Conditions for Toxic Exposures: VA has announced that starting Aug. 2, 2021, it began processing disability claims for asthma, rhinitis and sinusitis based on presumed particulate matter exposures during military service in Southwest Asia and other areas. These conditions must have manifested within 10 years of a qualifying period of military service. Major Medical Facility Bill Signed into Law: President Biden signed into law the Major Medical Facility Authorization Act of 2021. This change will authorize VA to carry out specific major medical facilities projects and increase the amount of money that can be spent on each project. The VFW applauds the passage of this legislation and calls on Congress and the Administration to continue rigorous oversight of VA's infrastructure needs. The VFW has testified numerous times on VA infrastructure and the need for proper attention to aging VA facilities DUMP Opioids Act Becomes Law: President Biden has signed S. 957, DUMP Opioids Act, into law. This law expands on VA's program to dispose of controlled substances introduced in the Isakson Roe Act of 2020. It will make VA's drop boxes accessible to the public with a community information campaign announcing designated times for disposal to improve medication safety in homes.

National Veterans Service National Veterans Service participated in a meeting with Veterans Benefits Administration to discuss the future of electronic notification of VA rating decisions. The VFW has been working closely with VA on standing up a new system through which Service Officers can more easily be notified of decisions for VFW claimants, providing feedback on the potential new system. National Veterans Service leaders met to discuss the upcoming NVS fall training conferences. Students for the accredited Service Officer training taking place in September are already starting to decide and NVS is planning to deliver its first in-person training since January 2020. Last week, NVS was notified that the Federal Circuit Court of Appeals threw out VA's regulations prohibiting veterans from preserving the effective dates of Supplemental Claims through the Intent to File process. The VFW has been vocal that restricting veterans from preserving effective dates for Supplemental Claims was harmful for veterans and contrary to what the VFW helped negotiate for the Appeals Modernization Act. The VFW is now following up with VA to learn what this change means for veterans affected by the prohibition since February 2019. VFW NVS Pre-Discharge Staff are once again hosting benefits briefings for transitioning service members at Joint Base Andrews and for transitioning Navy flag officers around the country. Final Notes: In light of all the difficult political situations that have transpired over the last 30 days, please keep focused on the help veterans who now serve in Afghanistan will need upon their return. Let's go all out and do what we can to expedite their issues if possible...... And let's say a pray for those veterans that are no longer with us.... Robbie

VMS Programs are an integral part of the VFW's never-ending obligation to assist members of the active-duty military, national guard and reserves, as well as their families. VMS is broken down into 3 distinct stand-alone programs.

- Unmet Needs
- Military Assistance Program (MAP)






