General Orders No. 3 2020-2021 Series

- Gangs: Gangs including any Motorcycle groups/units/gangs not officially affiliated with 1. the VFW or other Veterans Service Organizations are not allowed to wear or display their vests or "colors" at any Oklahoma VFW Post or business operation operated by or on the behalf of the Post unless voted upon by the Post membership at a regular or special meeting called for such purpose. Specifically, any gang including motorcycle group/unit/gang or its individual members that is identified as a 1% organization or is listed in the FBI Gang Threat Assessment is prohibited from wearing their vests or "Colors" at any Oklahoma VFW Post or business operated by or on behalf of the Post regardless of Post membership approval. This includes the group or unit hosting or attending an event or fundraiser even if it is for another organization on VFW property. https://www.fbi.gov/stats-services/publications/2011-national-gang-threatassessment#Appendix-A:%20Gangs%20by%20State
- 2. **Section 703:** The attention of Post Commanders, District Commanders and inspecting officers is directed to Section 703 of the National By-Laws - Bonds. Each accountable officer of this organization shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which they may be accountable. Liquid assets are defined as cash on hand or in the bank and other negotiable instruments readily convertible into cash.
- 3. **Section 1001:** The attention of all members is directed to the Manual of Procedure, Section 1001, paragraph 25 that states "The presence, dispensation, and/or consumption of alcoholic beverages or use of smoking/vaping products in VFW meeting rooms during VFW meetings are prohibited."

Reported violations of this order will be severely dealt with under the punitive provisions of the VFW National By-Laws. This practice by some Posts and Districts not only violates the ritual but also discredits the honored memory of our fallen comrades and is contrary to moral ethics based upon long and distinguished records of this organization. District Commanders are hereby charged with the responsibility of enforcement of this order and the duty of reporting violations thereof to the State Commander.

4. Pursuant to National By-Laws & MOP, Article X, Rules of Order, "The following Rules of Order shall govern all meetings. Any procedural matter not provided for by the Rules or Convention Rules shall be governed by the current Robert's Rules of Order, Newly Revised."

I hope everyone that is able has gotten their year into full swing. I know that the ongoing COVID pandemic is still limiting our ability to do our jobs 100%, so now is the time that we have to throw the book out and think outside of the box as was stated at the past two Schools of Instruction. For those who did not receive the email from Adjutant General Kevin Jones, National is currently experiencing a severe shortage of Buddy Poppies due to the pandemic affecting their production facilities. Because of this, Commander-in-Chief Hal Roesch has waived the Buddy Poppy requirement for the All American program. We currently have about 4k of Buddy Poppies at the State Headquarters, but most of them are already spoken for. At this time, I am going to wait out the situation to see if production will be able to resume. At the first of the year, I will reexamine whether I will waive our All State requirement for them. So, please stand by on that.

As some of you may know, our Oklahoma VFW Foundation generously donated \$5k to our Service Office program. We also received another \$5k donation from the Vietnam Veterans Association Chapter 216 of Tulsa for it. On behalf of the Department, I want to say a very big THANK YOU for the donations. With that being said, we are looking to hire a part time Service Officer to work at our Muskogee office. In order to do that, per our Department Bylaws, I am standing up the Veterans Service Committee again to ensure fair hiring practices are followed. This Committee will consist of PDC Darryl Mabry, Past National Surgeon General Curtis "Doc" Bohlman, NCM Robbie Clark, State Judge Advocate Gordon Wheeler and myself. So, if you or someone you know who is interested in applying for the position, please contact the State headquarters. More information on the job description will be forthcoming.

If you were able to attend one of the Schools of Instruction this past month, you heard from our hard charging Youth Activities Chair Erica Wilson-Traxler. She has worked hard to put


forward a strong program for you when it comes to VOD/PP/TOY/SVA. If you were not able to attend and would like her briefing, please contact her. Right now is when we need to be out there promoting these programs. I know everything is different right now due to school scheduling and the online aspect. However, again, think outside of the box. Get with your local papers, radio and TV to help promote these programs. Understanding the current situation and if you do not receive any entries, I will grant credit for a one of these programs provided you submit substantial evidence show you made every effort to promote the program. Remember, this is the future of our country we are reaching out to. They deserved all the help we can give them.

Membership. Yup, here we go. So as of this writing, the Department is currently at 13 of 14 in the Southern Conference and 32 out of 52 nationally when it comes to membership. Our highest recruiter to date has recruited 15 new members. We have 1 recruiter at 3, 6 at 2 and 19 at 1. Everyone should now be in possession of the At Large Roster for your area and the Retention Roster for your Post. If you have not received them yet, please contact your District Commander. These are amazing tools to use to increase you membership. Please, work every person on these rosters. *Remember 100% by December 31st*, 2020 and 110% by June 30th, 2021! We also have my Commander's Challenge for the first half of this year. The first Post to 100% by December 31st, 2020 will receive \$100. Every Post after the first, but before the deadline, will receive \$50. So, get out there and bring these new members in.

I would be remiss if I did not mention the Commander-in-Chief's Challenge for September. The top Post in each membership category at the end of the month will receive \$500. In addition, each Department that has a Post win will receive \$500. If the Department has more than one Post win, it will receive \$500 for every winning Post! So, again, work those rosters and let's bring in some bog dough for the Posts and the Department!

Our Department Centennial is April 16th, 2021. By this point, all of you should have received a card in the mail asking you to update your information and submit your picture and story to be added to our Centennial Memory book. I hope all of you have participated and have purchased a book. It is a great memento to have. Not many get to celebrate 100 years, so this is going to be an amazing experience for all of us. Speaking of mementos, our Centennial Coin design was released at the State Convention. District 1 Commander Matt Ward had the winning design. There was a manufacturing error in the first set, so the coins are currently being made and should be available with in the first week of the month. All the State Officers and District Commanders have preorder forms. They are two inches wide and the price per coin is \$20. Each coin will be individually numbered, and the current set is 500 coins. We would love to have to order another 500! So, get in contact with one of the state officers to reserve yours today!

Take care of yourselves out there TEAM OKLAHOMA! I wish you the best. Please continue what you are doing. I could not have asked for a better Department to command. Each of you are the tip of the spear and that is why we are "FIRST TO FIGHT FOR VETERANS!"

There are 14 Departments within the Southern Conference. We are currently 13th. There are 52 Departments within the Veterans of Foreign Wars. We are currently 32nd. Are you doing your best to recruit? We have some great recruiting opportunites planned down the road and we are always looking for more events. Well, if Covid-19 lets us. If you have a recruiting membership drive, please let us know. We have a lot of talented recruiters willing to assist you with your drives.

Recruit and Retain. You may have noticed that I talk a lot about retention. Bringing in a new member is good. But when you lose one or two out the back door, you are just spinning your wheels. You need to develop a plan to keep post members engaged. Have someone work as a greeter. They greet new and old members, talk to them, let them know that someone cares. Post members physically present and home bound members virtually present.

Sr. Vice Commander Mike Merit moved that the VFW Department Oklahoma endorse National Council Member (Georgia) Al Lipphardt, for National Jr. Vice Commander-in Chief. Motion carried.

Commander Darryl Mabry asked for any other nominations for State officer positions. No nominations were submitted. Commander Mabry declared nominations closed.

Voting of State Officers:

District # 15 Commander PSC Ken Pike moved that a Roll Call vote be used for elections. Seconded by PSC Jay Bjorgo.

<u>State Commander 2020-21:</u> Sr. Vice Commander Mike Merit was elected to the position of State Commander.

<u>Sr. Vice Commander 2020-21:</u> Jr. Vice Commander Jim Bassett was elected to the position of State Sr. Vice Commander.

Commander Mabry recessed for 5 minutes; Commander Mabry called convention to order.

<u>Jr. Vice Commander 2020-21:</u> Roll call vote was conducted, and Comrade Jeremy Owen was elected as State Jr. Vice Commander.

<u>State Surgeon 2020-21:</u> Comrade Jeff Harris removed his name from the elections for State Surgeon. State Adjutant Curt Watts cast one vote of acclamation for Stacy Reddig for State Surgeon.

Commander Mabry recessed for 5 minutes at 1445hrs; Commander Mabry called convention to order at 1450hrs.

<u>State Chaplain 2020-21:</u> Roll call vote was conducted, and Comrade Rick Willey was elected as State Chaplain.

<u>State Quartermaster 2020-21:</u> State Judge Advocate Gordon Wheeler cast one vote of acclamation for Curt Watts for State Quartermaster.

<u>State Judge Advocate 2020-21:</u> State Adjutant Curt Watts cast one vote of acclamation for Gordon Wheeler for Judge Advocate.

Commander Mabry recessed for 5 minutes at 1500hrs; Commander Mabry called convention to order at 1505hrs.

<u>State Budget & Finance Committee Member 2020-21:</u> Roll call vote was conducted, and Comrade John Fischer was elected as 3-year Budget & Finance Committee Member.

<u>Immediate Past State Commander 2020-21:</u> State Adjutant Curt Watts cast one vote of acclamation for Darryl Mabry for Past State Commander.

Installation of Department Officers was conducted at 1515hrs by National Surgeon General Curtis (Doc) Bohlman.

State Commander Mike Merit spoke to the convention delegates and briefly discussed his plans for VFW year 2020-21.


Closing Ceremonies were conducted pursuant to National By-Laws, Manual of Procedures & Rituals.

Chaplain's Note

The word equinox is ultimately derived from the Latin word *aequinoctium* meaning "equal days and nights."

FROM THE NATIONAL COUNCIL MEMBER

Member Services the Member Service Center will be preparing for the VFW fiscal year-end beginning Monday, Aug. 31, 2020, at 11:30 a.m. CST. VFW Store orders, dues payments, installment payments, installment enrollment, magazine subscriptions, member transfers, and member updates will be taken, but will experience a slight delay in processing. National expects to resume normal processing on Friday, Sept. 4, 2020. Human Resources New Employee: Please welcome Devon Wilcher to the VFW. Devon is our new National Pre-Discharge Claims Representative at Camp Pendleton, California. National Legislative Service NLS is working to secure the inclusion of the Major Richard Star Act in the upcoming National Defense Authorization Act for Fiscal Year 2021. Last week, the president signed into law VFW- supported H.R. 3504, the Ryan Kules and Paul Benne Specially Adaptive Housing Improvement Act of 2019. The new law will provide enhancements to VA's Specially Adapted Housing program by increasing the number of

grants awarded, raising the dollar amount of the individual grants, and expanding the number of times qualified veterans can use a housing grant. This change will help certain severely disabled veterans purchase adaptive homes or upgrade existing homes to meet their specific needs for daily living activities. The VFW currently supports 157 pieces of legislation pending before the 116th Congress. Contact: VFW National Legislative Service Director Patrick Murray, PMurray@vfw.org. Communications and Public Affairs Finalized production of The VFW Podcast Episode 001; Episode 002 production underway. Planning meetings set with Department of Veterans Affairs officials to discuss efforts to conduct a VFW- VA Facebook Live event centered around "Combatting Veteran Homelessness" scheduled for September. National leadership attended the Secretary of Veterans Affairs Weekly COVID-19 briefing for VSOs. **Operations** VFW representatives met with Department of South Carolina student veteran rep to discuss their support for the upcoming second annual 22Kfor22 Ruck March on Sept. 19, 2020, in Florence, South Carolina. This annual event is held to raise awareness for mental health and addiction issues that affect our veterans, ultimately resulting in us losing 22 of our heroes each day. Also met with Remington Hotels who have immediate openings for veterans and spouses at numerous locations across the country. National Veterans Service National Veterans Service spoke with the VA Office of Inspector General regarding the implementation of the <u>Blue Water</u> Navy Vietnam Veterans Act. During the discussion, NVS raised concerns over losing optics on benefit decisions due to the abrupt elimination of pre-decisional review for VSOs. NVS continued its planning for virtual training conferences in the fall. Students required to attend the virtual Advanced Skill Level Training (VASLT) have started to confirm participation for next month's online training conference. NVS joined the Toyota Veterans Association to brief on veterans' benefits, providing a quality baseline for TVA leadership in advance of a more in-depth briefing to TVA membership this October. NVS continued to provide virtual benefits briefings to transitioning service members, this week participating in events for Washington Navy Yard and Joint Base Myer-HendersonHall. National Security & Foreign **Affairs** National Security and Foreign Affairs staff is reaching out virtually to the legislative staffs of House and Senate conferees for the 2021 National Defense Authorization Act to continue advocating for the following amendments and issues: Concurrent Receipt - The VFW is disappointed that expansion of concurrent receipt was not included in either version of the NOAA, and will continue to pursue concurrent receipt improvements to ultimately ensure full military retired pay and veterans' disability compensation for all disabled retirees.

MTF Restructuring/Medical Billet Cuts-The VFW supports <u>H.R. 6395</u>, Sec. 715 and Sec. 716. We understand COVID-19 has forced a delay to MRS reform efforts, but we believe legislation is needed to ensure both MTF restructuring and proposed medical billet cuts allow for transparency, greater DOD reporting requirements, and congressional oversight. Military Pay Raise - The VFW is pleased that both the House and Senate are reinforcing the fundamental comparability principle with a 3% raise for FY2021. We will continue to address restoration of 2.6% in accumulated losses from pay raises that lagged Employment Cost Index between 2014 and 2016 in our

recommendations for future budgets. **TRICARE Waiver Authority during National Emergencies** - The VFW supports <u>S. 4049</u>, Sec. 723. The COVID-19 pandemic has demonstrated it is crucial to authorize DOD to waive or modify TRICARE policy or regulation during a declared national emergency. **TRICARE Extended Care Health Option Program-The** VFW supports

H.R. 6395, Sec. 706. It is important to align TRICARE ECHO program coverage with state Medicaid waivers, consistent with recommendations from the 2015 MCRMC report. Addition of Three Agent Orange Presumptives - The VFW supports S. 4049, Sec. 1090B. Bladder cancer, hypothyroidism, and Parkinsonism meet the scientific threshold to be associated with exposure to Agent Orange. These presumptives will extend crucial care and benefits to tens of thousands of veterans. **Last Minutes thoughts:** First: For District Commanders! Membership Retention packages have all been priority mailed, with tracking, to you. If you did not receive a package, please notify Retention Chairman Robbie Clark immediately. The packages contain files for every post in your district to assist in retaining prior members. Second: What with COVID 19 being a huge topic these days, we all may need to think about planning our time, as best we can, to get jobs done. That includes not only what we do for the VFW, but how we plan other taskings. Ever feel there is never enough time for getting everything done these days? Here is a decent way to generally plan time both at home and helping at VFW Posts, Districts and Department levels or other organizational support work:

- 1. Regular time (should take about 65% of your available time) i.e. Primary taskings that are NOT delegated. You are the one that does it.
- 2. Routine time (should take about 10%) i.e., Work that CAN BE delegated ("Son, please mow the lawn")
- 3. Special time (should take about 10%) i.e., This does not directly support any home or organizational missions i.e., Maybe take a rest break!!
- 4. Creative time (should take about 15%) i.e., Doing something that results in improvement: at borne, in supporting other issues, in yourself/spouse/children,etc.


