First, I hope this finds all of you and your family healthy and well. If not, I pray for a speedy recovery. Hey! Here we are beginning our fouth month of the year. I hope everyone that is able has gotten their year into full swing. I know that the ongoing COVID pandemic is still limiting our ability to do our jobs 100%, so now is the time that we must throw the book out and think outside of the. Any other clubs that are not veteran related or 1% groups must be approved by the Post membership. That is a very simple process to do. While we have not had any directly related interference from these groups, they have begun to move out of North Texas and into Oklahoma. As your Commander, it is my sworn duty to protect this Department, its Posts and its members in any way I can. Plain and simple, that is what I am doing. In no way, shape or form am I being discriminatory concerning riders. We have a lot of great people out there who are riders and do many great things. However, a very small group are not and we cannot allow that in our organization.

Fall Festival: We are having a very special Fall Festival this year. Not only will National President Sandi Onstwedder be in attendance for part of it, our National Commander-in-Chief Hal Roesch will be attending as well. Let's get as many people to Fall Festival to show them what Oklahoma is all about. We will also be initiating and installing a new Cootie Auxiliary on Saturday, so we will have officers from Cootie Supreme with us. (BOO!) On Saturday night, there will be a roaring 20's party, so bring your best 20's costume and lets have some fun!

Last month I stood up the Veterans Service Committee again to ensure fair hiring practices are followed when it comes for filling the vacancies we have in the assistant service officer position in Muskogee. This Committee consists of PDC Darryl Mabry, Past National Surgeon General Curtis "Doc" Bohlman, NCM Robbie Clark, State Judge Advocate Gordon Wheeler and myself. We have received a few interested members, but no applications to date. So, if you or

someone you know is interested in applying for the position, please contact the State headquarters. More information on the job description will be forthcoming.

We are in the final stretch of the youth programs. They come to an end this month at the Post level. I know everything is different right now due to school scheduling and the online aspect. However, again, think outside of the box. Get with your local papers, radio and TV to help promote these programs. Understanding the current situation and if you do not receive any entries, I will grant credit for a one of these programs provided you submit substantial evidence show you made every effort to promote the program. Remember, this is the future of our country we are reaching out to. They deserved all the help we can give them.

Membership Update. September end numbers are as follows: Southern Conference, Oklahoma is #1. Nationally, Oklahoma is #16. We still have 1,814 to go to that magic 100% before the end of the year. That is approaching fast! Remember, keep working those At Large Lists and the Retention Lists you all have received. Our highest recruiter to date, State Chaplain Stacy Reddig has recruited 24 new members. We have 1 recruiter at 15, 3 at 4, 2 at 3, 10 at 2 and 25 at 1. Our overall breakdown is 62 new members, 40 reinstates and 45 without a recruiter. Quartermasters, please ensure you are entering a recruiter number when putting in new members so the right person gets the credit for them. *Remember 100% by December 31st, 2020 and 110% by June 30th, 2021!* We also have my Commander's Challenge for the first half of this year. The first Post to 100% by December 31st, 2020 will receive \$100. Every Post after the first, but before the deadline, will receive \$50. Post 7740 will receive the \$100. So far 1048, 8676 and 4465 will receive \$50 each. So, get out there and bring these new members in. There's still plenty of time to win some money for your Post!

A couple pieces of legislative info I am helping our State Senior Vice out with. The Department begun working with the National American Indian Veterans, Inc. to help them with Congress to received their federal charter just as our organization has. It is known as S4715 and is sponsored by Senators Rounds and Thune of South Dakota. We have contacted our congressional delegation asking the to support it as well. If you would like more information on the bill or would like a letter to send to them, please contact me and let me know. In addition, after some discussion with several state legislators, we know have the support to introduce the Veteran Lottery Bill in the State Legislature this upcoming session. It would be a huge boost to all the VSOs in Oklahoma and as more news develops, we will keep you posted.

Our Department Centennial is April 16th, 2021. By this point, all of you should have received a card in the mail asking you to update your information and submit your picture and story to be added to our Centennial Memory book. I hope all of you have participated and have purchased a book. It is a great memento to have. Not many get to celebrate 100 years, so this is going to be an amazing experience for all of us. Speaking of mementos, our Centennial Coin design was released at the State Convention. The coins are in and a lot have already been distributed. All the State Officers and District Commanders have preorder forms. They are two inches wide

and the price per coin is \$20. Each coin will be individually numbered, and the current set is 500 coins. We would love to have to order another 500! So, get in contact with one of the state officers to reserve yours today!

Take care of yourselves out there TEAM OKLAHOMA! I wish you the best. Please continue what you are doing. I could not have asked for a better Department to command. Each of you are the tip of the spear and that is why we are "FIRST TO FIGHT FOR VETERANS!"

Halloween is a fun time. Kids running around in costumes, laughing and giggling. Eating way too much candy. They all compare costumes and start planning on the next years. Even adults get dressed up. Either as something fun or really scary. Halloween is a fun time to be a child. I don't know what will happen this year with the children and Halloween, but I do want you to remember to be cautious. Stay home that night, avoid the little ones in the street and, if you hand out candy, wear a mask! Look for what your community puts out for Halloween. Remember, Covid is still with us. So please! Post members physically present and home bound members virtually present.

In case you missed it, this is an election year. Things are getting heated up when people discuss politics. Please don't get dragged in to a discussion of politics if you are wearing VFW items. I attended a fundraiser and recruiting drive in August. I was floored because a middle aged lady came up to me and asked how the VFW was leaning politically. I explained to her that we encourage our members to register and vote how they see fit. I further explained that our politics concentrate solely on legislation that impacts veterans, regardless of the political party. She was happy with that answer and actually donated to us. Please remember, we do not support a party or candidate. You are encouraged to register, and to vote for any candidate or party you desire. The VFW's concern is the erosion of benefits that veterans receive. Please keep an eye on legislation that impacts your benefits. One way to do that is through knowledge and not hearsay. 41 Posts under suspension, one of which is new. We received one new submission for a Post consolidation and processed one pursuant to Section 209 of the National Bylaws. One Charter surrender was completed pursuant to Section 210 of the National Bylaws. The organization currently has 6,074 active chartered Posts. Administrative Operations is engaged in 15 Article IX Disciplinary Actions, seven administrative actions and five pending membership eligibility challenges. This past week we received 17 new Bylaws/Articles of Incorporation submissions in for review. We also reviewed and approved 18 total Bylaws/Articles of Incorporation submissions and currently have 19 submissions pending review and approval. Current turnaround time on Bylaws/Articles of Incorporation submissions is approximately 14 days. **Publications VFW** magazine received two Awards of Excellence in the 2020 APEX Awards for Publication Excellence competition. Vietnam's Montagnard's in America was honored in the Writing Series category, while Female Veteran *Entrepreneurs* was recognized in the Feature Writing category. APEX is sponsored by the Alexandria, Virginiabased Communications Concepts. Meetings and Events Continuing to participate in weekly educational virtual meetings/webinars/ZOOMs pertaining to meetings industry updates. Participated in a Virtual Site Visit/Forum for St. Louis, Missouri, that provided an update on the city e.g. new hotels, convention center updates, etc. The meeting provided introductions to individuals representing convention center and hotels. Ongoing weekly ZOOM call with various meeting planners and supplier's discussions on state of the industry, ideas exchange and overall encouragement during this time. Ongoing - weekly ZOOM call with ALHI hotels and presentations of the current state of the meetings industry as provided by CEO/President Michael Dominguez. His presentation includes overall updates on COVID-19. Sources include Johns Hopkins and CDC. Current week includes a video presentation by Dr. Deborah Birx on status of therapeutics and vaccines. Preparation of list of cities to forward RFP (Request for Proposal) for convention city bids for 2025 and 2026, (process done every other year). Target date to forward is Sept. 28, 2020. Sent list of national convention committees to National Chairman Brian Sturgis for his chairmen appointments for those committees. Later, will determine when first 'virtual' committee meeting will be held to review committee duties and responsibilities. Forwarded Hilton Crystal City contract (VOD/2021) to legal for their final review and signatures. Note: Holiday Inn Rosslyn is closed for two years for renovation resulting in the need to find a new location for the group. Hilton is near the Hyatt Crystal City where the legislative conference is held. Operations Attended the Veterans Day National Committee (VDNC) meeting to discuss the upcoming event and limited VSO participation due to COVID-19. Each primary member of the VDNC will be allowed one (1) person to represent their organization at the Veterans Day event. Director of Operations Tony Lowe will represent the VFW at the Arlington National Cemetery event on Nov. 11. Attended the Brookings Institute webinar on "The Needs of America's Post 9/11 Veterans", where the Wounded Warrior Project (WWP) unveiled the results of their 11th Annual Warrior Survey and hosted a discussion about the most pressing issues facing America's service members and veterans. National Security & Foreign Affairs NSFA has been working this week with other VSOs to negotiate with the Defense Health Agency to achieve a 12-month reinstatement period with coverage retroactive to Jan 1, 2021, for TRICARE Select beneficiaries who may miss communication on the new enrollment fee and fail to establish a payment mechanism when the change goes into effect on Jan. 1, 2021. To remind our Council members, the FY2017 National Defense Authorization Act (NDAA) established TRICARE Select and included a new enrollment fee (\$150 for individual and \$300 for family) for Group A retirees that would take effect Jan. 1, 2021. During the FY17 NDAA process, VFW and other VSO's successfully defeated a TRICARE for Life enrollment fee and an even higher proposed Select enrollment fee (\$450 for individual and \$900 for family). National Veterans Service This week, National Veterans Service concluded its first Virtual Advanced Skill Level Training conference, where more than 70 of the VFW's most experienced service officers received continuing education on a variety of VA benefit topics. NVS will continue its virtual learning next month with its first Virtual Basic Service Officer training and in November with a Virtual Intermediate Skill Level Training conference. NVS staff participated in a series of meetings related to the delivery of care to veterans, including a meeting with Veterans Health Administration officials to discuss the ongoing implementation of the MISSION Act Community Care Program. NVS Deputy Director Dawn Jirak and Assistant Director for Health Policy James Moss participated in a virtual meeting of the VA Voluntary Service National Advisory Committee.
